

Protection of Personal Data Clarification Text

ŞTİ; We take the highest level of security measures in order to collect, store and share your personal data in accordance with the law within the scope of activities arising from the Personal Data Protection Law No.6698 ("KVKK") and related legislation and legal regulations.

As DEMİR BİLGİTEKNOLOJİ SAN. VE TİC. LTD. ŞTİ, we have prepared this text to inform you as our stakeholders such as our employees, visitors, suppliers, customers and potential customers within the scope of the importance we attach to the privacy and security of personal information, under Article 10 of the Personal Data Protection Law No. 6698.

Method and Legal Reason of Collecting and Keeping Personal Data

Demir BİLGİTEKNOLOJİ, collects your personal data provided from third parties and legal authorities including you, partnerships, group companies, affiliates, solution partners with whom we cooperate or have a contractual relationship; for you to communicate with our company and/or establish your legal relationship during the continuation of this relationship through call centers, internet, mobile applications, social media and other public channels or training, organizations and similar activities, in order to provide the above-mentioned purposes and services within the scope of the provisions of Articles 5, 6 and 8 of the Law.

The personal data specified above of our company employees, are collected for the legal interests of the data controller and for signing a contract with them.

The personal data specified above of our interns, are collected for the legal interests of the data controller.

The personal data specified above of our employee candidates, are collected for the legal interests of the data controller and foreseen in the laws.

Our visitors' information such as identity (name, surname), and contact (e-mail, telephone) is collected in order to fulfill our legal obligations.

Our suppliers' identity (name, surname), contact (address, telephone number, e-mail, IBAN) information are collected for the legal interests of the data controller.

The personal data specified above of product and/or service purchasers were collected within the scope of signing contracts with our customers and the legal interests of our institution, which is the data controller.

The personal data specified above of our potential customers has been collected within the scope of the legal interests of our institution, which is the data controller.

Rights of Personal Data Owner enumerated in Article 11 of Law No. 6698

The personal data owner has the rights to:

Learn whether personal data is processed or not,

Request related information if personal data has been processed,

Learn the purpose of processing personal data and whether they are used appropriately for their purpose,

Know the third parties to whom personal data are transferred domestically or abroad
Request correction of personal data in case of incomplete or incorrect processing and reporting of the aforementioned process to the third parties to whom personal data is transferred,

Request the deletion or destruction of personal data in the event that the reasons for its processing disappear, and to request notification of the transaction made within this scope to third parties to whom personal data has been transferred, although it has been processed in accordance with the provisions of Law No. 6698 and other relevant laws,

Object to the occurrence of a result against the person themselves by analyzing the processed data exclusively through automated systems,

Request the compensation of the damage in case of damage due to the unlawful processing of personal data,

You can transmit your request to use the above-mentioned rights in Turkish and in writing or by using registered electronic mail (KEP) address, secure electronic signature, mobile signature or the electronic mail address previously notified to the COMPANY and registered in our system, in accordance with the paragraph 1 of Article 13 of the Law No. 6698 and the Communiqué on Application Procedures and Principles for Data Controller dated 10.03.2018. Only information about the applicant will be given in the applications, and it will not be possible to get information about other family members and third parties. The COMPANY reserves the right to verify your identity before responding.
